Definitions and interpretation

1. In this privacy policy, the following definitions are used:

Data	collectively all information that you submit to Mike Hall Coaching Ltd via the Website. This definition incorporates, where applicable, the definitions provided in the Data Protection Laws;
Cookies	a small text file placed on your computer by this Website when you visit certain parts of the Website and /or when you use certain features of the Website. Details of the cookies used by this Website are set out in the clause below (Cookies);

User or you	any third party that accesses the Website and is not either (i) employed by Mike Hall Coaching Ltd and acting in the course of their employment or (ii) engaged as a consultant or otherwise providing services to Mike Hall Coaching Ltd and accessing the Website in connection with the provision of such services; and

- 2. In this privacy policy, unless the context requires a different interpretation:
 - a. the singular includes the plural and vice versa;
 - b. references to sub-clauses, clauses, schedules or appendices are to sub-clauses, clauses, schedules or appendices of this privacy policy;
 - c. a reference to a person includes firms, companies, government entities, trusts and partnerships;
 - d. "including" is understood to mean "including without limitation";
 - e. reference to any statutory provision includes any modification or amendment of it;
 - f. the headings and sub-headings do not form part of this privacy policy.

Scope of this privacy policy

- 3. This privacy policy applies only to the actions of Mike Hall Coaching Ltd and Users with respect to this Website. It does not extend to any websites that can be accessed from this Website including, but not limited to, any links we may provide to social media websites.
- 4. For purposes of the applicable Data Protection Laws, Mike Hall Coaching Ltd is the "data controller". This means that Mike Hall Coaching Ltd determines the purposes for which, and the manner in which, your Data is processed.

Data collected

Data that is given to us by you

- 7. Mike Hall Coaching Ltd will collect your Data in a number of ways, for example:

Data that is collected automatically

Our use of Data

- 10. We may use your Data for the above purposes if we deem it necessary to do so for our legitimate interests. If you are not satisfied with this, you have the right to object in certain circumstances (see the section headed "Your rights" below).
- 11. When you register with us and set up an account to receive our services, the legal basis for this processing is the performance of a contract between you and us and/or taking steps, at your request, to enter into such a contract.

Who we share Data with

- 12. We may share your Data with the following groups of people for the following reasons:
 - a. our employees, agents and/or professional advisors To allow the provision of life coaching services;
 - b. third party payment providers who process payments made over the Website to enable third party payment providers to process user payments and refunds;

in each case, in accordance with this privacy policy.

Keeping Data secure

- 13. We will use technical and organisational measures to safeguard your Data, for example:
 - a. access to your account is controlled by a password and a user name that is unique to you.
 - b. we store your Data on secure servers.

- 15. Data retention

- 17. Even if we delete your Data, it may persist on backup or archival media for legal, tax or regulatory purposes.

Your rights

- 18. You have the following rights in relation to your Data:

If we provide you with access to the information we hold about you, we will not charge you for this, unless your request is "manifestly unfounded or excessive."
